

Shannon Murdock is the Republican judicial candidate for the Seventh Judicial District Court for the upcoming 2018 general election.

On July 10, 2018 Judge Shannon Murdock was presiding at the Socorro County Courthouse. At or around at 2:30 p.m., she along with her staff member/court monitor, Denise Lujan, attended the ground breaking of the Veguita Health Clinic in Veguita, Socorro County, NM and actively campaigned at said event while on judicial time. This type of activity is contrary to the Government Conduct Act. See Sections 10-16-3.1, 10-16-4 & 10-9-21.

Judge Murdock and staffer attended said event while on judicial time, and may have utilized a state vehicle during said event as parties were returning to the Torrance County Court House, their respective County of residence. Judge Murdock's staffer was present and took pictures of the event. See Keep Judge Shannon Murdock for Judge Campaign Facebook site @ <https://www.facebook.com/keep.shannon.murdock/> and posts enclosed herein evincing she attended said event; enclosed docket sheet evincing that Judge Murdock had a docket that same day at the Socorro County Court House, Socorro, NM. See also email invite of said event evincing day, time and place of said event, enclosed herein.

Moreover, review of Judge Murdock's campaign finance report does not reveal any "gas" expenditures during said event or her campaign in total, thus implying that she does not expend any campaign resources nor any "in kind" expenditures thus implying unlawful campaign finance reporting, or she utilized state/judicial vehicle for campaign travel. See CFIS.state.nm.us. This is contrary to the Financial Disclosure Act. See Section 10-16A-1 through 8.

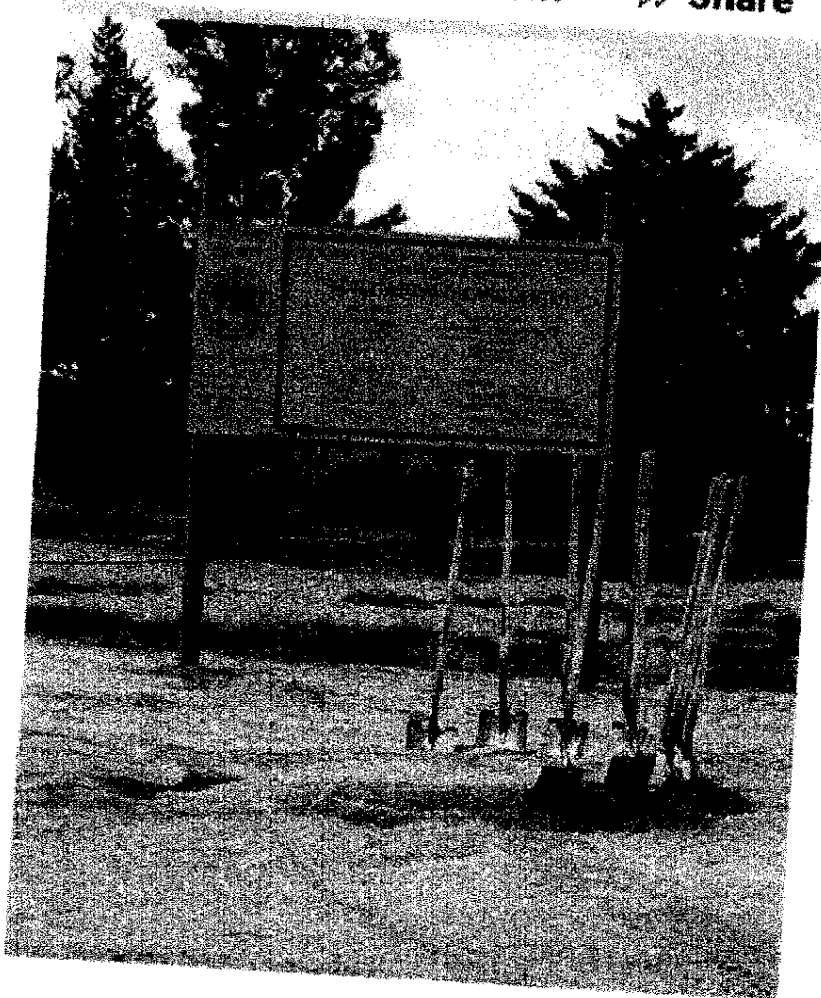
